- Each participating employee will receive a full, one-year family membership to Seven Ponds Nature Center, with all the benefits of a full membership (value = \$50/employee).
- Additional employees may be added during the year; if additional employees bump the employer into the next Business Membership level, employer must pay the difference.
- Employer must provide a completed Employee Enrollment Form for each participating employee.
- Employee members are expected to follow the rules of the nature center and treat the building and grounds with respect; failure to do so may result in the termination of the employee and/or business membership.
- Seven Ponds Nature Center reserves the right to terminate this program at the conclusion of the year-long membership.
